The New Dutch Governance Model

Mildred Hofkes, Director of BHRM and founder of NewGovernance, developed this model based on her interviews with 100 CEO's. The results were published in the book "Wisseling van de Macht" (Changing Power) in 2009.

Nowadays, the concept of reputation transcends the superficial 'storytelling' campaigns that only cover the exterior aspects of companies and organizations. Booming Vietnam

This year Holland is celebrating 40 years of diplomatic relationship with Vietnam. Dutch economic activity were boosted in 2011 when Willem Alexander and Maxima visited the country together with a Dutch business delegation. A counter visit from the Vietnamese vice president to Holland took place in 2012.

We are the largest European investor in Vietnam. Especially in water management and purification, maritime infrastructure, oil & gas and transport & logistics. Dutch exports are growing in machinery, chemicals, food and beverages. Vietnam is the third market in the world for Heineken, after the US and Mexico and is even bigger than in The Netherlands.



Growing market

"Retained search is a growing market in Vietnam" says Simon Fraser, Managing Partner of IRC Vietnam. "Many Vietnam-based companies are discovering they simply don't have the resources to find the right people to match the business arowth.

Often the best suited Vietnamese candidates are living outside Vietnam – in Europe, North America and Australia. These candidates have bargaining power" he adds, "as they generally have good language skills, an education, life skills and work experience – we're looking for them." Simon sees immediate growth opportunities in health, education and manufacturing, with banking and finance developing further in the following years. "Japanese and Korean companies are moving from China to Vietnam, finding it more cost-effective for business, especially in manufacturing."

Earlier this year MSD, one of the largest pharmaceutical companies in the world, opened a new office in Hanoi: Jan Van Acker, CEO of MSD Vietnam: "Despite the general impacts of the economy, Vietnam is still a dynamic and attractive market for foreign companies. Although the past 10 years, there have been many advances in the medical field, but still a significant number of patients do not have access to the health care and medicine in the best way.

Prior to that fact, we always set out their mission is to provide the difference for patients in Vietnam. With the opening of a new office in Hanoi, Vietnam MSD will have a more favourable position to collaborate with partners and colleagues in the north to meet the needs of the health care particular people and areas in the whole territory of Vietnam in general."
